1. RELATIONSHIP TO GOVERNMENT:

- Is a division within the Ministry of Cultural Development (MoCD) located at the "Te Puna Korero Sir Geoffrey Henry Culture Centre". Was established in 1992 but became fully operational in 1993 with a collection of just over 10,000 books comprising mainly of:
- Children's Fiction and Non Fiction
- Adult Non-Fiction
- Reference Collection
- Cook Islands and Pacific Books, Reports and Theses
- A very small collection of Pacific rare books
- Has a dual function that of a National and a Public Library
- The National Library has a very strong relationship with all the outputs within the Ministry of Cultural Development. The Ministry has four main events in the year where each output is required to assist Output 1. The National Library plays a big role in support of the events where the service of staff is highly needed in the areas of: ticket sales and


promotions. A lot of time is involved with the preparation and the duration of an event.


2. FACTS AND FIGURES:

- The National Library of the Cook Islands was established in 1992 and became fully operational in 1993 with a collection of just over 10,000 books. It has the dual function of a National and Public library.
- There are only two staff including myself, both un-qualified librarians with on the job experience only. Not many people are qualified librarians in the country and the only upskilling of the staff was through the short-term training with other Libraries in New Zealand being offered through the Human Resources Department here in the Cook Islands funded by the department and . I, on a couple of occasions, have had the opportunity to go on training, once with the Alexander Turnbull Library and the Auckland Council Library. This training was beneficial and I am always looking for more opportunities like this whenever available.
- I have looked at other options of taking online library courses and made contact with LIANZA last year to see what they had to offer. I was so interested to take the courses but not having the funding to pay for the courses discouraged me. It is my hope to become a qualified librarian one day and maybe through this report, I could be able to get assistance from one of the CDNL-AO countries.
- A total budget of \$NZ5,250 per annum (since 2012) is allocated for the National Library from Government. This budget is very low and it is mainly used for our operating. The intention of the National Library is to look at international agencies who offer grants where we can request or apply for funding to assist in developing or building the resources within the National Library.
- A trading revenue of \$3,000 per annum had to be generated by the National Library. It is difficult for the National Library to generate this kind of revenue as there is a limited number of services and resources available.

3. A BRIEF GENERAL OVERVIEW OF RECENT MAJOR DEVELOPMENTS:

The National Library started developing a legal deposit policy and bill a in 2012. The advice and assistance of personnels from the National Library of New Zealand and Auckland Council Library were incorporated and discussed with National Depository Committee members to help develop the legal deposit draft policy and the legal deposit draft bill. The draft policy and bill were completed in 2014 and was handed over to the Head of Ministry for next level of development.

However, 2015 being the 50th year of self-government meant that the Ministry of Cultural Development became one of the key Ministries with the preparation of the Independence events for the whole year. Therefore, the progress of the legal deposit was then put on hold.

The National Library is now looking at other ways to build its National collection (listed below) instead of depending on the legal deposit.

4. NEW DEVELOPMENTS IN BUILDING AND MANAGING COLLECTIONS:

- 1. Having the National Library as the main depository for:
 - All Government agencies publications either in hard or electronic copies especially on the main island of Rarotonga
 - Private sectors on the main island of Rarotonga which includes audio visual what things are deposited?
 - All schools on the main island of Rarotonga

- More promotional awareness about the National Library available through the media
- 7. NOTES ON YOUR COLLABORATION WITH OTHER LIBRARIES, ARCHIVES AND MUSEUMS IN YOUR COUNTRY: The National Library together with the National Archives and National Museum are all divisions within the Ministry of Cultural Development. The collaboration between these divisions is very strong in terms of sharing of information as well as assisting each other in the promotion and exhibition of many activities and events.

The National Library also collaborates with some government department and school libraries assisting them mainly with the setting up of their small libraries. Most government departments have many published materials but

have no idea how to set up or even use the dewey decimal cataloguing system for the numbering of their books.

8. NOTES ON INTERNATIONAL COLLABORATION:

- There is no formal arrangement for cooperation with other international libraries or organization. However, the National Library have created relationships with other international libraries and organizations.
