#### 5. Building/Managing/Proving Access to Collections

- a. Through the Asia and Oceania Section of the NLP Memorandum of Agreements (MOAs) have been renewed or newly entered MOA between NLP and the following countries.
  - China A China Book Room has been constructed and inaugurated on December 6, 2012. An exchange agreement of books in print and non-print form between National Library of China, Confucius Institute was entered between the two national libraries.
  - Iran The Philippine Iranian Studies Center located in the NLP through a Memorandum of Agreement signed several years ago has been re-negotiated between the National Library of Iran and the NLP.
  - Korea An existing arrangement of exchange in publications, reading materials, visits as well as training by virtue of an International Cultural Agreement has been existing and implemented. The idea of constructing a Window's of Korea (WOK) in the NLP is being negotiated.
  - USA Through the American Shelf Program the US Embassy through the Thomas Jefferson Cultural Center, supplemental books and some furniture and equipment have been donated to the NLP.
- b. Through the Information Technology Division (ITD) of the NLP, the latter facilitated the remote access through the Phil-eLib Project of the Government and continues to assist affiliated libraries in the deployment of computers and provide the continuous training of librarians for KOHA Open Source Integrated Library System. The NLP plan to include in its reorganization an expanded Digital Library Services Division.
- c. The NLP has drafted through the assistance of other government agencies, proposed bills for possible legislations in the aim of revisiting and updating library legislations affecting the NLP. These are:
  - Amendment to Republic Act No. 7160, otherwise known as the Local Government Code, to make the appointment of public librarians mandatory, and
  - An Act Modernizing the National Library of the Philippines, Strengthening Its Powers and Functions, and for Other

# B. Collaborations with Other Institutions (Libraries, Archives and Museums)

- 1. Affiliating Regional, Provincial, Congressional, Cities, Municipal Public Libraries and Barangay Reading Centers through a Memorandum of Agreement with Local Government Units allocating materials to the same. As of 2012 there are 1,396 affiliated libraries throughout the country.
- 2. Collaborating with the National Archives of the Philippines, National Historical Commission of the Philippines, National Museum, Cultural Center of the Philippines and the other cultural agencies under the administrative supervision of the National Commission for Culture and the Arts in the implementation of Republic Act No. 10066 otherwise known as the National Heritage Protection Act of 2009.
- 3. Coordinating with the National Committee of Libraries and Information Services (NCLIS) the Annual Search for Outstanding Libraries in the Philippines.
- 4. Coordinating with the Philippine Librarians Association, Inc. (PLAI) the celebration of the National Library Day, National Book Week and the Library and Information Services Month in November of each year as mandated by Presidential Proclamations.
- Assisting in the implementation of Republic Act No. 9246 or The Philippine Librarianship Act of 2003 mandating the Licensure Examination for Librarians.
- 6. Deputizing the Intellectual Property Office (IPO) in the registration of Copyright registration and receiving deposits to augment the NLP collection as mandated by the Intellectual Property Code of the Philippines.
- 7. Serves as the National Center for ISBN, ISSN and ISMN Numbering System.

### **II. Library Profession**

#### A. Library Association

- 1. Philippine Librarians Association, Inc. (PLAI) is the national association of professional librarians. It has sixteen chapters throughout the country called Regional Librarians Council.
- The present PLAI National President is Elizabeth Peralejo of Ateneo de Manila High School. The President leads the National Board of Trustees (NBOT) of PLAI.
- 3. PLAI had conducted a National Congress/General Assembly and National Conference held in General Santos on November 28-30, 2012 on the theme "The Libraries...Effects on Society".

#### B. Librarians Licensure Examination and Legislation

- 1. Republic Act No. 9246 or the Philippine Librarianship Act of 2003 created the Professional Regulatory Board (PRB) for librarians under the Professional Regulation Commission (PRC) of the Philippines.
- 2. To date twenty one (21) examinations were conducted and the total registered/professional licensed librarians is 6884.
