The library is considered a specialized and scientific institution due to its great importance in the dissemination of knowledge. Many thinkers and experts have worked in this field and presented theories, one of them is Shiyali Ramamrita Ranganathan.

Ranganathan's Five Laws of Librarianship is one of the most enduring works in library and information science texts. These five principles are: 1. Books are for use. 2. Every reader his [or her] book. 3. Every book its reader. 4. Save the time of the reader. 5. The library is a growing organism (Illangarathne& Yingming, 2015).

The fifth principle is the fundamental principle and indicates that it should govern their planning, programing and organization.

The above principles clearly express the philosophy that knowledge increases, people need knowledge and the function of the library is to provide this knowledge (Mukherjee, 2003).

The fifth law can be interpreted in connection with its effect on employees and their skills. Along with the growth of the library in terms of services, the skills needed to provide new services will also grow (Christ, 1987).

The national library of any country is considered the mother library of that country, and in its most complete state, it is the mirror of the entire spiritual culture of that nation.

In terms of the importance of the national library in every society and the everincreasing information needs of the society and the need to obtain useful information at the right time, it expresses.

The National Library is planning and guiding the flow of information in the country and is a reference and authoritative library for researchers inside and outside the country.

In the more general definition of sustainable development as a process, it requires improvement and progress, a process that is the basis of improving the situation and eliminating socio-cultural deficiencies (Salami, 2016).
